Board and committee reports:

Currently a one time payment of \$100 is due for Level 4-6 gymnasts by September 10th. For optional gymnasts, this fee is due by December 17th. Future payments are dependent on fundraising.

ASU Training Camp: Andrew would like girls to attend this camp during the winter holiday break. He is investigating possibility of working camp for a reduced fee for our gymnasts. Kristie to look into dates, cost etc.
